SUBJECT: Medicaid Training for Speech/Language Pathologists, Physical Therapists, Physical Therapy Assistants, Occupational Therapists, Occupational Therapy Assistants, School Psychologists, and Contracted Personnel Providing ESE Services

The Department of Exceptional Student Education will offer mandatory (new hires) and refresher Medicaid service documentation training for staff providing direct services to students with disabilities who qualify for Medicaid eligible services referenced in their Individual Education Plans.

Participants attending the Mandatory Initial Training should register on the District's Course Registration.
